The following revisions have been made to the plans:

New Sheet Nos. 2-T and 2-U are being added to provide a temporary pavement design. Please staple the new Sheet Nos. 2-T and 2-U after Sheet No. 2-S in your plans.

Sheet No. 3-M has been revised to correct the "Summary of Pavement Removal." Please void Sheet No. 3-M in your plans and staple the revised Sheet No. 3-M thereto.

The following revisions have been made to the proposal form:

On Page No. 1, the completion date has been revised in the project special provision entitled "Contract Time and Liquidated Damages." Please void Page No. 1 in your proposal and staple the revised Page No. 1 thereto.

On Page No. 82, the date for utility adjustments by Progress Energy has been revised. Please void Page No. 82 in your proposal and staple the revised Page No. 82 thereto.

On Page No. 1 of the item sheets, the quantity for line item "13-015600000-M-250 Removal of Existing Asphalt Pavement" has been revised. By copy of this addendum, the quantity is hereby increased from 4,575 M2 to 7,500 M2. The Contractor's bid price must be based on this revised pay item quantity. The Contract will be prepared accordingly.

**CONTRACT TIME AND LIQUIDATED DAMAGES:**

**07-20-99**

The date of availability for this contract is January 31, 2005, except that work in jurisdictional waters and wetlands shall not begin until a meeting between the DOT, Regulatory Agencies, and the Contractor is held as stipulated in the permits contained elsewhere in this proposal. This delay in availability has been considered in determining the contract time for this project.

The completion date for this contract is October 15, 2007.

When observation periods are required by the special provisions, they are not a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. Should an observation period extend beyond the final completion date, the acceptable completion of the observation period shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are One Thousand Five Hundred Dollars (\$1,500.00) per calendar day.

**INTERMEDIATE CONTRACT TIME NUMBER 1 AND LIQUIDATED DAMAGES:**

The Contractor shall not close or narrow a lane of traffic on **NC 87**, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

**HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS:**

1. For **any event** that creates unusually high traffic volumes, as directed by the Engineer.
2. For **New Year's Day**, between the hours of 1:30 p.m. December 31st and 8:30 a.m. January 2nd. If New Year's Day is on Saturday or Sunday, then until 8:30: a.m. the following Tuesday.
3. For **Easter**, between the hours of 1:30 p.m. Thursday and 8:30 a.m. Monday.
4. For **Memorial Day**, between the hours of 1:30 p.m. Friday and 8:30 a.m. Tuesday.
5. For **Independence Day**, between the hours of 1:30 p.m. the day before Independence Day and 8:30 a.m. the day after Independence Day.

If Independence Day is on a Saturday or Sunday, then between the hours of 1:30 p.m. the Thursday before Independence Day and 8:30 a.m. the Tuesday after Independence Day.
