Reference is made to the plans and proposal form recently furnished to you on the abovementioned project.

The following revisions have been made to the plans:

Sheet Nos. EC-1, EC-3 and EC-4 have been revised to meet the design standards for sensitive watersheds. Please void Sheet Nos. EC-1, EC-3 and EC-4 in your plans and staple the revised Sheet Nos. EC-1, EC-3 and EC-4 thereto.

The following revisions have been made to the proposal form:

New Page No. 86-A is being added to include a letter of refinement to the CAMA Permit. Please staple new Page No. 86-A after Page No. 86 in your proposal.

On Page No. 3 of the item sheets, the quantity for line item number "40-6009000000-E-1610 Stone for Erosion Control, Class B" has been revised. By copy of this addendum, the pay item quantity is hereby increased from 120 Ton to 145 Ton. Also on Page No. 3 of the item sheets, the quantity for line item number "47-6030000000-E-1630 Silt Excavation" has been revised. By copy of this addendum, the pay item quantity is hereby increased from 35 CY to 355 CY. The Contractor's bid price should be based on these revised pay item quantities. The contract will be prepared accordingly.

RE: Refinement of CAMA Major Development Permit No. 91-04 (TIP No. B-3884). Replacement of Bridge No. 40 on SR 1308 over Squires Run in Onslow County.

Dear Dr. Thorpe:

This letter is in response to the N.C. Department of Transportation's (NCDOT's) letter dated July 2, 2004 regarding clarification of the wetland clearing methods for the subject project.

The permit application drawing Sheet 4 of 7 depicted the type of clearing in wetlands to be mechanized clearing. Condition No. 22 was applied to CAMA Permit No. 91-04 to address mechanized clearing, by requiring annual updates on the cleared wetlands re-attainment of jurisdictional status. According to your letter, the wetland clearing area shown in the permit drawing was mislabeled as being mechanized clearing, and only hand clearing methods will be utilized. As a result, this Letter of Refinement expunges Condition No. 22 from CAMA Permit No. 91-04.

In addition to the above refinement, Condition No. 17 is modified to read as follows:

17) Design Standards for Sensitive Watersheds will be used in accordance with the 4/14/04 CAMA Permit application form DCM-MP-5, Section 4(e).

This Letter of Refinement must be attached to the original CAMA Permit No. 91-04, which was issued on June 21, 2004, and both documents must be readily available on site when a DCM representative inspects the project for compliance. All conditions and stipulations of the active permit remain in force unless altered herein.
