The following revisions have been made to the proposal form:

On page no. 31 the project special provision entitled "Shoulder Construction" has been deleted. Please void page no. 31 in your proposal and staple the revised page no. 31 thereto.

On page no. 1 of the item sheets, line item "3-1243000000-E-SP Shoulder Construction" has been deleted. Also on page no. 1 of the item sheets the quantity for line item "4-1245000000-E-SP Shoulder Reconstruction" has been revised. By copy of this addendum, the pay item quantity is hereby increased from 37.3 SMI to 47.48 SMI. The Contractor's bid price must be based on the revised pay item quantities. The Contract will be prepared accordingly.

Revise the 2002 Standard Specifications as follows:

Page 2-20, Article 230-6

After the first paragraph, insert the following paragraph:

"No direct payment will be made for the work of Evaluation of Potential Wetlands and Endangered Species as outlined above. Payment at the contract unit price for the pay item 'Borrow Excavation', 'Grading – Lump Sum', or 'Shoulder Reconstruction' will be considered full compensation for this work."
