The following revisions have been made to the proposal form:

On Page No. 1 of the item sheets, the quantity for line item "13-4686000000-E-1205 Thermoplastic Pavement Marking Lines (4", 120 MILS)" has been revised. By copy of this addendum, the pay item quantity is hereby decreased from 68,900 LF to 64,900 LF. The Contractor's bid price must be based on this revised pay item quantity.
