# PROJECT SPECIAL PROVISIONS Utility Construction

All proposed utility construction shall meet the applicable requirements of the NC Department of Transportation's "Standard Specifications for Roads and Structures" dated July 2006. Division 15 of the Standard Specifications is

revised as follows:

## Page 15-1, Paragraph 4

Provide access for Department personnel and the owner's representatives to all phases of construction. Notify Department personnel and the utility owner two weeks prior to commencement of any work and one week prior to service interruption. Keep utility owner's representatives informed of work progress and provide opportunity for inspection of construction and testing. The water lines on this project belong to Alexander County, and are operated and maintained by the City of Hickory. The owner's representative is Mr. Kevin Grier, Public Utilities Director with the City of Hickory. Mr. Grier can be reached by telephone at (828) 323-7427.

#### Owner's Requirements

## PROJECT SPECIAL PROVISIONS Utility

### **UTILITIES BY OTHERS:**

#### General:

The following utility companies have facilities that will be in conflict with the construction of this project.

- A) Duke Power Power Distribution
- B) AT & TNC Telephone

The conflicting facilities of these concerns will be adjusted prior to the date of availability, and are therefore listed in these special provisions for the benefit of the Contractor. All utility work listed herein will be done by the utility owner. All utilities are shown on the plans from the best available information.

The Contractor's attention is directed to Article 105-8 of the Standard Specifications.

Utilities Requiring Adjustment:

- A) Duke Power Power Distribution
  - 1) Duke Power will remove its poles and lines and relocated them to permanent locations as shown on the Utilities prior to Others Plans by date of availability.
  - 2) Contact person for Duke Power is Mr. Cregg Parks at 828-323-2819.
- B) AT & T NC Telephone
  - AT & T NC will remove its poles, overhead lines, and abandon its buried underground lines at the existing locations within the project limits and install new buried cable and overhead lines at the locations shown on Utilities by Others Plans prior to date of availability.
