All utility work listed herein will be done by the utility owner and completed no later than March 31, 2009. All utilities are shown on the plans from the best available information.

Utilities Requiring Adjustment:

A) AT&T – Telephone

- 1) AT&T will install, adjust, abandon or remove its facilities at the locations within the project limits as shown on the Utility by Others Plans. A two week installation period for aerial relocation is required, after the City of Lumberton has completed construction approximately November 26, 2008.
