This project was originally scheduled for a September 15, 2009 bid opening. It was decided to extend the advertisement, make some changes and open bids on Tuesday, September 29, 2009 at 2:00 PM.

Reference is made to the proposal and sketch maps furnished to you on this project.

The following revisions have been made to the Proposal:

The bid opening date on the proposal cover sheet has been revised from "September 15, 2009" to "September 29, 2009".

On Page No. 1 the completion date for the Project Special Provision entitled "Intermediate Contract Time Number 1 and Liquidated Damages" has been revised.

On Page Nos. 37 thru 41 the Project Special Provision entitled "Final Surface Testing-Asphalt Pavements (Rideability)" has been deleted.

On Page No. 41 the first paragraph of the Project Special Provision entitled "Patching Existing Pavement" has been revised.

On Page No. 45 the Project Special Provision entitled "Adjustment of Manholes" has been added.

On Page No. 49 the Project Special Provision entitled "Traffic Control" has been revised.

On Page No. 1 of the item sheets, by copy of this addendum the quantity for line item "10-1704000000-E-SP Patching Existing Pavement" has been increased from 185 TON to 685 TON. On Page No. 2 of the item sheets, by copy of this addendum the quantity for line item "16-4810000000-E-1205 4" Paint Pavement Marking Lines" has been increased from 37,167 LF to 68,414 LF. Also on Page No. 2 of the item sheets, by copy of this addendum the following two new pay items are hereby added: "22-2830000000-N-858 Adjustment of Manholes (Quantity = 49EA) and "23-2845000000-N-858 Adjustment of Meter Boxes and Valve Boxes (Quantity = 45EA). The Contractor's bid must be based on these revised quantities and new pay items. The contract will be prepared accordingly.

The Expedite File has been updated to reflect the change of let date. Do not use the EBS file you previously downloaded. Please download the new Expedite EBS file associated with the September 29, 2009 letting and then download and apply the addendum file dated 9/18/09. Bid Express will not accept your bid unless the new EBS file is used and the addendum has been applied.


The following revisions have been made to the sketch maps:
