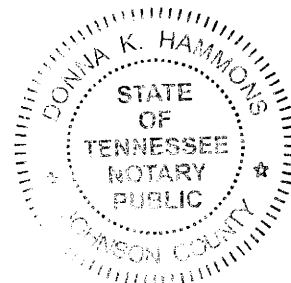

DEBARMENT CERTIFICATION OF CONTRACTOR

Conditions for certification:
