- C) PROVIDE FOR DETOUR SIGNING WITHIN AND OFF THE PROJECT LIMITS.
- D) COVER OR REMOVE ALL DETOUR SIGNS WITHIN AND OFF THE PROJECT LIMITS WHEN A DETOUR IS NOT IN OPERATION.
- E) ENSURE ALL NECESSARY SIGNING IS IN PLACE PRIOR TO ALTERING ANY TRAFFIC PATTERN.


F) PLACE TYPE III BARRICADES, WITH "ROAD CLOSED" SIGN R11-2 ATTACHED, OF SUFFICIENT LENGTH TO CLOSE ENTIRE ROADWAY.

## PHASING

STEP 1: USING RSD 1101.03, SHEET 1 OF 9, SHEETS TCP-3 AND SD-1, INSTALL DETOUR SIGNS, PLACE TYPE III BARRICADES TO CLOSE SR-1105 (PINEBLUFF LAKE RD) TO THROUGH TRAFFIC, AND DETOUR TRAFFIC OFFSITE.

STEP 2: AWAY FROM TRAFFIC, COMPLETE THE FOLLOWING:

- 1) REMOVE EXISTING STRUCTURE (NO. 176) AND CONSTRUCT PROPOSED STRUCTURE FROM -L- STA. 14+15 TO STA. 15+50. SEE ROADWAY PLANS.
- 2) CONSTRUCT PROPOSED ROADWAY UP TO AND INCLUDING FINAL SURFACE COURSE LAYER FROM -L- STA 12+30 TO STA 17+50 AND TIE INTO EXISTING PAVEMENT MARKINGS.
- 3) PLACE FINAL PAVEMENT MARKINGS FROM -L- STA. 12+30 TO -L- STA. 17+50 AND TIE INTO EXISTING PAVEMENT MARKINGS.
- STEP 3: REMOVE ALL TRAFFIC CONTROL DEVICES AND DETOUR SIGNING. OPEN SR-1105 (PINEBLUFF LAKE RD) TO PROPOSED TRAFFIC PATTERN.
