If there is any deviation as originally submitted, the town requires that DOT furnish an "as Built" copy.

## **UTILITY CONFLICTS:**

General:

The following utility companies have facilities that will be in conflict with the construction of this project:

- A. PROGRESS ENERGY-POWER
- B. CENTURY LINK-TELEPHONE
- C. SUDDEN LINK-CABLE

The conflicting facilities of these concerns will be adjusted prior to the date of availability, unless otherwise noted and are therefore listed in these special provisions for the benefit of the Contractor. All utility work listed herein will be done by the utility owners. All utilities are shown on the plans from the best available information.

The Contractor's attention is directed to Article 105.8 of the Standard Specifications.

Utilities Requiring Adjustment:

#### A. Progress Energy

The Contractor's attention is directed to the fact that Progress Energy has conflicts within the project limits. The primary conflicts are shown on plan sheet UO-4. Progress Energy will complete temporary work that will permit construction access by March 1, 2011. During this temporary phase, the Contractor will be required to work around several poles that may be in conflict with construction.

Permanent work to completely clear Progress Energy conflicts will be completed by June 15, 2011.
