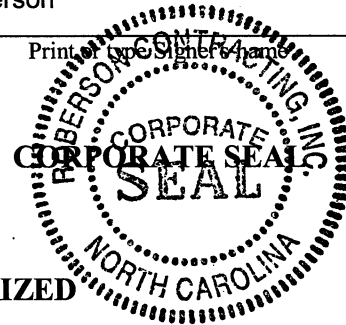

DEBARMENT CERTIFICATION





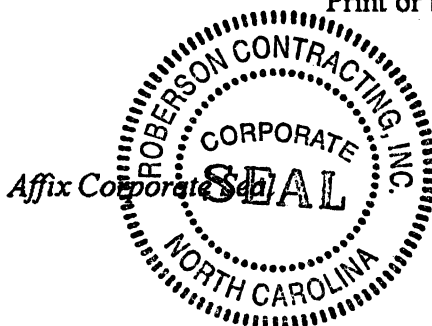
