Surface all unpaved intersections back from the edge of the pavement on the mainline of the project at least 50 feet, or as directed by the Engineer. Surface all driveway and mailbox turnouts as directed by the Engineer. Place pavement in the intersections of the same material and thickness as being used on the mainline. Use material to pave driveway and mailbox turnouts that are being used on the project and place it in depths directed by the Engineer. The unpaved intersections, driveways, and mailbox turnouts will be prepared for surfacing by the Contractor.

Resurface all paved intersections back to the ends of the radii, or as directed by the Engineer. Widen the pavement on curves as directed by the Engineer.

Revise the 2006 Standard Specifications as follows:

Division 2 Earthwork

Page 2-16, Subarticle 230-1(D), add the words: The Contractor specifically waives as the first words of the sentence.

Page 2-17, Article 230-4(B) Contractor Furnished Sources, first paragraph, first sentence replace with the following:

Prior to the approval of any borrow sources developed for use on any project, obtain certification from the State Historic Preservation Officer of the State Department of Cultural Resources certifying that the removal of the borrow material from the borrow sources(s) will have no effect on any known district, site building, structure, or object, architectural and/or archaeological that is included or eligible for inclusion in the National Register of Historic Places.
