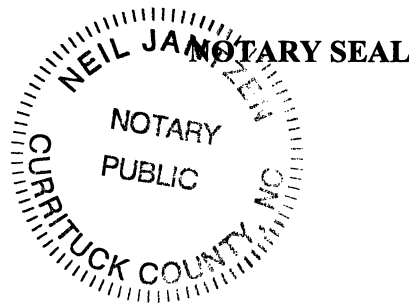

DEBARMENT CERTIFICATION




