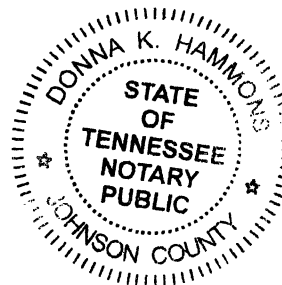

DEBARMENT CERTIFICATION
