ROADWAY

SHOULDER RECONSTRUCTION:

The Contractor shall place ABC (M) along the completed edge of pavement and construct shoulders as shown on the sketch map and/or as directed by the Engineer. The area shall be backfilled and compacted to the satisfaction of the Engineer.

The ABC (M) shall meet the requirements of Section 1005 in the NC DOT Standard Specifications for Roads and Structures.

This work shall be defined as "Shoulder Reconstruction" and the quantity of such work to be paid for will be the actual number of shoulder miles which have been constructed. Measurement will be made along the edge of each shoulder. Measurement will be made to the nearest 0.01 of a mile.

The quantity of shoulder reconstruction measured as provided above, will be paid for at the contract unit price per shoulder mile for "Shoulder Reconstruction".

Page 6-26, Subartical 610-8 Spreading and finishing: delete the fourth paragraph and replace with the following:

Use a material transfer vehicle (MTV) when placing all intermediate and surface asphalt concrete plant mix pavements regardless of asphalt binder grade and for all types of OGFC, unless otherwise approved. Use a MTV on all Interstate, US and NC routes that have four lanes or more and median divided, and on two lane facilities that can safety used to be directed by the project engineer. Where required above, use the MTV when placing all full travel width travel lanes and collector lanes. Use MTV for all ramps, loops, Y lines travel lanes, full width acceleration lanes, full width deceleration lanes and full width turn lanes that are greater than 1,000 ft. in length. Use a MTV meeting section 9.5 (E) of the HMA/QMS Manual.

RESURFACING EXISTING BRIDGES:

The Contractor's attention is directed to the fact that he will be required to resurface the bridges on this project if directed by the Engineer.

Place the surface so as to follow a grade line set by the Engineer with the minimum thickness as shown on the sketch herein or as directed by the Engineer. State Forces will make all necessary repairs to the bridge floors prior to the time that the Contractor places the proposed surfacing.

Give the Engineer at least 15 days notice prior to the expected time to begin operations so that State Forces will have sufficient time to complete their work.

At all bridges that are not to be resurfaced, taper out the proposed resurfacing layer adjacent to the bridges to insure a proper tie-in with the bridge surface.

<u>PAVING INTERSECTIONS, DRIVEWAYS, AND MAILBOX TURNOUTS:</u> (7-1-95)

Surface all unpaved intersections back from the edge of the pavement on the mainline of the project at least 50 feet, or as directed by the Engineer. The base material for all intersections to be surfaced will be prepared for surfacing by State Forces. Place pavement in the intersections of the same material and thickness as being used on the mainline.

Surface all paved intersections back to the ends of the radii, or as directed by the Engineer. In addition, the Contractor will be required to resurface all driveway and mailbox turnouts as directed by the Engineer.

Page 10-162, Subarticle 1081-1(B) Requirements, lines 26-30, replace the second paragraph with the following:

For epoxy resin systems used for embedding dowel bars, threaded rods, rebar, anchor bolts and other fixtures in hardened concrete, the manufacturer shall submit test results showing that the bonding system will obtain 125% of the specified required yield strength of the fixture. Furnish certification that, for the particular bolt grade, diameter and embedment depth required, the anchor system will not fail by adhesive failure and that there is no movement of the anchor bolt. For certification and anchorage, use 3,000 psi as the minimum Portland cement concrete compressive strength used in this test. Use adhesives that meet Section 1081.

List the properties of the adhesive on the container and include density, minimum and maximum temperature application, setting time, shelf life, pot life, shear strength and compressive strength.

Page 10-169, Subarticle 1081-3(G) Anchor Bolt Adhesives, delete this subarticle.

Page 10-204, Subarticle 1092-2(A) Performance and Test Requirements, replace Table 1092-3 Minimum Coefficient of Retroreflection for NC Grade A with the following:
