Revise the *2012 Standard Specifications* as follows:

**Page 1-20, Subarticle 102-15(O)**, delete and replace with the following:

**(O)** Failure to restrict a former Department employee as prohibited by Article 108-5.

**Page 1-65, Article 108-5 Character of Workmen, Methods, and Equipment, line 32**, delete all of line 32, the first sentence of the second paragraph and the first word of the second sentence of the second paragraph.

**STATE HIGHWAY ADMINISTRATOR TITLE CHANGE:**

Revise the *2012 Standard Specifications* as follows:

Replace all references to "State Highway Administrator" with "Chief Engineer".

**NOTES TO CONTRACTOR:**

The Town of Beulaville is currently planning to replace a water main on Map 2 (NC 41) between Milepost 30.89 (Southern City Limits of Beulaville) and Milepost 31.48 (NC 24). The Contractor on this project cannot proceed with the work on this section until September 4, 2013 or after. Should the Town of Beulaville be unable to replace the water main prior to September 4, 2013, then Typical Section Number 8 (full depth patching and mill patching) shall be used on this section. Should the Town of Beulaville replace the water main prior to September 4, 2013, then Typical Section Number 4 (4" mill and fill) shall be used on this section.

The *Standard Specifications*, Article 104-5, "Overruns and Underruns of Contract Quantities" is amended to exclude the item of "Borrow Excavation".

The *Standard Specifications*, Article 610-7, "Hauling of Asphalt Mixture" is amended to include the following: "All covers shall extend down over the sides and back of the vehicle body for a distance of 12 inches and shall be securely fastened."

**For all maps where widening is being done, the pavement marking edge lines shall be reinstalled at their current location to insure the widening serves as a paved shoulder.**
