PROJECT SPECIAL PROVISIONS

Utility Construction

I. GENERAL CONSTRUCTION REQUIREMENTS:

Specifications:

The proposed utility construction shall meet the applicable requirements of the NC Department of Transportation's "Standard Specifications for Roads and Structures" dated January 2012, Brunswick County Utilities, The City of Southport, and the Southeast Brunswick Sanitary District specifications, and the following provisions. Should a conflict arise between the referenced standards, the most stringent requirement shall apply.

The Contractor shall be responsible for field verifying location, size, type and elevation of all underground utilities, as well as reconnecting any water and/or sanitary sewer services disturbed during construction, even if they are not shown on the plans. The water line shall be installed as to provide a minimum of 3 feet of coverage above the top of pipe from finished grade, unless shown differently on plans. The Contractor shall verify that all new water and sanitary sewer lines have ten (10') feet horizontal clearance between each other.

The Contractor is herein forewarned as to the possibility of having to vary the depth of the pipeline installation to achieve minimum clearance of existing or proposed utilities or storm drainage while maintaining minimum cover specified (whether existing or proposed pipelines, conduits, cables, mains, storm drainage are shown on the plans or not).

Connecting to existing water mains may alter such lines to the extent that these pipelines with existing pipe bends, valves and other related appurtenances may also require reaction blocking; this is also the responsibility of the Contractor.

Revise the 2012 NCDOT Standard Specifications as follows:

Page 15-6; Sub-article 1510-3 (B) Testing and Sterilization; change allowable leakage formula to:

W=LD(P)1/2/148,000

Page 15-6; sub-article 1510-3 (B) Testing and Sterilization; seventh paragraph, delete the words "concurrently or" in the following sentence:

Testing, cleaning and sterilization may be performed *concurrently or* consecutively.

Concrete Pier

Concrete piers shall be used to support pipes at all stream crossings, where, in the opinion of the Engineer, such piers are necessary. Such piers shall be constructed as shown on the utility plans.

The concrete shall meet the requirements of Section 1000 of the Standard Specifications and the 28 day compressive strength shall meet or exceed 3,600 psi.

Steel for straps and bolts shall be AISI type 316 stainless steel.

Measurement and Payment (Concrete Pier)

Each Concrete Pier will be measured and paid for as each. Such price and payment will be full compensation for all work covered by this provision, including but not limited to labor, materials, pier construction, excavation, backfilling, and incidentals necessary to complete the work as required.

Reconnect Sewer Force Main Service

All pressure sewer service connections installed as identified in the construction plans shall be connected to the force mains with equal diameter or 1 ¼" SDR 9 PE or as indicated on the plans.

Measurement and Payment (Reconnect Sewer Force Main Service)

Each Reconnect Sewer Force Main Service will be measured and paid for as each. Such price and payment will be full compensation for all work covered by this provision, including but not limited to labor, materials, excavation, backfilling, and incidentals necessary to complete the work as required.

II. COMPENSATION:

No direct payment will be made for utility construction work required by the preceding provisions, which are general requirements applying to utility construction, and all of the requirements stated will be considered incidental work, paid for at the contract unit prices of the various utility items included in the contract.
