## **Hazardous Materials Report**

The GeoEnvironmental Section of the Geotechnical Engineering Unit has investigated the above referenced project to identify hazardous material sites for inclusion in the environmental document.

## **HAZARDOUS MATERIALS EVALUATION**

## **Purpose**

This section presents the results of a hazardous material evaluation conducted along the above referenced project. The main purpose of this investigation is to identify properties within the project study area that are or may be contaminated and therefore result in increased project costs and future liability if acquired by the Department. Hazardous material impacts may include, but are not limited to, active and abandoned underground storage tank (UST) sites, hazardous waste sites, regulated landfills and unregulated dumpsites.

## **Techniques/Methodologies**

The Geographical Information System (GIS) was consulted to identify known sites of concern in relation to the project corridor. Geotechnical Engineering Unit personnel conducted a field reconnaissance along the project corridor on March 6, 2012. A search of appropriate environmental agencies' databases was performed to assist in evaluating sites identified during this study.

## **Findings**

#### **UST Facilities**

Four (4) petroleum UST sites were identified within the project limits.

#### **Hazardous Waste Sites**

No Hazardous Waste Sites were identified within the project limits.

## Landfills

No apparent landfills were identified within the project limits.

## **Other GeoEnvironmental Concerns**

Three (3) other geoenvironmental concerns, all automotive repair facilities, were identified within the project limits.

## **Anticipated Impacts**

Four (4) UST facilities and three (3) automotive repair facilities were identified within the proposed project corridor. We anticipate low monetary and scheduling impacts resulting from these sites. (See the following table and appendices for details)

This building currently houses the American Legion Post 14. It is located southeast side US 29 (South Main street and across from the intersection with Cedar Springs Road. A heating oil tank is located on the northwest side of the structure and is located approximately 60 feet from the South Main Street median. This parcel does not appear on the UST Section registry and no groundwater incidents are associated with this operation. **This site is anticipated to present low geoenvironmental impacts to the project.**

This former store and possible gas station is abandoned. It is located on the southeast side of US 29 (South Main Street) and just northeast of the Cedar Springs Road intersection. The front of the structure is 55 feet from the South Main Street median. This property does not appear on the UST Section registry and no evidence of USTs was observed. A single vent line is located on the southwest side of this structure. **This site is anticipated to present low geoenvironmental impacts to the project.**

The facility currently operates as an automotive repair shop and a used car lot. According to tax records the building was first used as a warehouse. It is located in the south quadrant of the US 29 (South Main Street) and Peach Orchard Lane intersection. This property does not appear on the UST Section registry and no evidence of USTs was observed. However numerous vehicles are located on site making field observations difficult. This site is anticipated to present low geoenvironmental impacts to the project.

This business used above ground lifts. **This site is anticipated to present low geoenvironmental impacts to the project.**

This currently closed facility once operated as a warehouse. It is located on the north side of US 29 (South Main Street) and between the intersections of Peach Orchard Lane and Peach Orchard Road. According to the UST Section registry one UST was closed in 1994. A ground water incident #14244 was assigned to this property at that time. The incident was closed out in 2001. This site is anticipated to present low geoenvironmental impacts to the project.

This property does not appear on the UST Section registry and no other evidence of USTs was observed. This site is anticipated to present low geoenvironmental impacts to the project.

It is located in the south quadrant of Peach Orchard Road and NCRR/NS Railroad intersection. This property does not appear on the UST Section registry and no evidence of USTs was observed. This site is anticipated to present low geoenvironmental impacts to the project.
