To Whom It May Concern:

Reference is made to the plans furnished to you on this project.

The following revisions have been made to the plans:

- On Sheet No.S-2: the 11th note in the first column of the general notes was revised to require epoxy coated bar supports in the barrier rail.
- On Sheet No.S-8: Ten additional pairs of required 2 ½" dowel holes were added to be in agreement with the dowel placement shown on sheet S-13.
- On Sheet No.S-9: The following two notes were added:

"PRESTRESSED CONCRETE CORED SLAB UNITS ARE DESIGNED FOR 0 PSI TENSION IN THE PRECOMPRESSED TENSILE ZONE UNDER ALL LOADING CONDITIONS".

"PRESTRESSED CONCRETE CORED SLAB UNITS SHALL CONTAIN CALCIUM NITRITE CORROSION INHIBITOR IN ACCORDANCE WITH THE STANDARD SPECIFICATIONS."

- On Sheet No.S-27: the 11th note in the first column of the general notes was revised to require epoxy coated bar supports in the barrier rail.
- On Sheet No.S-33: Ten additional pairs of required 2 ½" dowel holes were added to be in agreement with the dowel placement shown on sheet S-38.
- On Sheet No.S-34: The following two notes were added:


