Reference is made to the plans and proposal furnished to you on this project.

The following revisions have been made to the plans:

Sheet Nos. EC-10, EC-11, EC-15, EC-33 thru EC-37, EC-58, EC-59, EC-73, EC-79, RF-1 and RF-2 have been revised to add additional areas of reforestation and to add notes to install berm ditches earlier in the project construction and in order to obtain the Trout Buffer Zone Waiver. Please void Sheet Nos. EC-10, EC-11, EC-15, EC-33 thru EC-37, EC-58, EC-59, EC-73, EC-79, RF-1 and RF-2 in your plans and staple the revised Sheet Nos. Dear Mr. Blackburn:

This office has received your plan for US 21 from SR 1000 (Oklahoma Rd.) to SR 1121 (Pine Swamp Rd.), in Alleghany County, North Carolina. Your plan was submitted to this office for approval because of the proposed encroachments into the buffer zone of designated trout waters. In accordance with NCGS 113A-57(1) and Title 15A NCAC 4B .0125(c) this letter will serve as written approval to encroach on the buffer zone of Laurel Branch, Class C, Trout, Unnamed Tributaries to Little Glade Creek, Class C, Trout, Glade Creek, Class C, Trout and Unnamed Tributaries to Glade Creek, Class C, Trout. This authority has been delegated to me by Tracy E. Davis, Director, Division of Energy, Mineral and Land Resources, in accordance with NCGS 143B-10. The following conditions will apply to this approval:

- 1. This approval is based on the plans received August 15, 2013 and revisions received via electronic message on January 9, 2014.
- 2. No land disturbing activity may take place within the trout buffer zone from October 15 to April 15 of each year.
- 3. Submit two (2) complete sets of final plans to the Winston-Salem Regional Office for their files.

- 4. Schedule a Preconstruction Conference with the Winston-Salem Regional Office before initiating any land-disturbing activity.
- 5. This approval does not absolve the permittee from compliance with the surface water quality turbidity standard. More protective erosion and sedimentation control measures may be required in order to comply with this water quality standard.
