LICENSING BOARD FOR CONTRACTORS WHEN BIDDING ON ANY NON-FEDERAL AID PROJECT WHERE THE BID IS \$30,000 OR MORE, EXCEPT FOR CERTAIN SPECIALTY WORK AS DETERMINED BY THE LICENSING BOARD. BIDDERS SHALL ALSO COMPLY WITH ALL OTHER APPLICABLE LAWS REGULATING THE PRACTICES OF ELECTRICAL, PLUMBING, HEATING AND AIR CONDITIONING AND REFRIGERATION CONTRACTING AS CONTAINED IN CHAPTER 87 OF THE GENERAL STATUTES OF NORTH CAROLINA. NOTWITHSTANDING THESE LIMITATIONS ON BIDDING, THE BIDDER WHO IS AWARDED ANY FEDERAL - AID FUNDED PROJECT SHALL COMPLY WITH CHAPTER 87 OF THE GENERAL STATUTES OF NORTH CAROLINA FOR LICENSING REQUIREMENTS WITHIN 60 CALENDAR DAYS OF BID OPENING.

NOTES TO CONTRACTOR

- 1) Novo Nordisk will allow controlled access to their property. This access will be limited and coordinated through the Department.
- 2) Contractor will be required to follow NCDOT reclamation procedures for borrow/waste staging areas for construction if land disturbing activities occur within the Contractor laydown areas.
- 3) Contractor shall maintain access to all Church services for the New Bethel Baptist Church.
- 4) The Railroad crossing just to the south of the proposed bridge on Plan Sheet 6 has been removed and is no longer useable.
