- 1. FOR GENERAL ABBREVIATIONS SEE DWG. NO. E-2.
- 2. DESK AND PINNACLE SHALL BE FABRICATED FROM 11 GAUGE STAINLESS STEEL WITH SATIN FINISH. SIDES TO BE 11 GAUGE PAINTED STEEL.
- 3. THE CONTRACTOR SHALL USE THE LAYOUT VIEW AS A GUIDE TO INSTALLING THE ELECTRICAL COMPONENTS. IF REQUIRED, THE CONTRACTOR SHALL RELOCATE COMPONENTS TO ALLOW FOR PROPER INSTALLATION OF THE COMPONENTS.
- 4. ALL CORNERS AND EDGES SHALL BE ROUNDED AND SMOOTH.
- 5. BOTTOM OF DESK TO BE OPEN EXCEPT FOR TWO INCH FLANGE FROM SIDES ALL AROUND PERIMETER. FASTEN CONTROL DESK TO FLOOR WITH 1/2" BOLTS THROUGH FLOOR. LEVEL DESK DURING INSTALLATION AND GROUT OR CAULK AROUND PERIMETER.
- 6. PROVIDE 2 FLUORESCENT LIGHT FIXTURE INSIDE THE CONTROL DESK WITH STANDARD 18" BULB PROTECTED BY A CLEAR, NON YELLOWING PLASTIC LENS. LIGHTS SHALL BE AUTOMATICALLY CONTROLLED BY DOOR SWITCHES ACTIVATED BY EACH DOOR.
- 7. PROVIDE DUPLEX RECEPTACLE 15 AMP, 125 VAC, FEDERAL SPEC GRADE INSTALLED IN STANDARD UTILITY BOX WITH METAL COVER PLATE.
- 8. ACCESS DOORS SHALL BE PAN TYPE FLUSH WITH DESK SURFACE AND HAVE FLUSH HANDLES WITH 3-POINT LATCHES. THE DOORS SHALL BE LOCKABLE.
- 9. INTERNAL COMPONENTS SHALL BE MOUNTED ON BACK PANELS. BUSHED OPENINGS SHALL BE PROVIDED FOR CONDUCTORS ACCESS. FIELD CONNECTIONS TO CONTROL RELAYS AND PILOT DEVICES SHALL BE BY MEANS OF TERMINAL BLOCKS WITHIN THE ENCLOSURE.
- 10. CONTROL SWITCHES, PUSHBUTTONS, INDICATING LIGHTS AND OTHER EQUIPMENT MOUNTED ON THE CONTROL DESK SHALL BE WIRED TO TERMINAL STRIPS
- 11.PROVIDE A SUPPORT CHAIN FOR THE SWING DOWN TOP PANEL.
- 12.PROVIDE HYDRAULIC SUPPORTS FOR THE DESKTOP MAIN PANEL TO SUPPORT THE PANEL AND HOLD IT IN THE RAISE POSITION WHILE WORKING ON THE PANEL. THE HYDRAULIC SUPPORTS SHALL BE MOUNTED ON BOTH SIDES OF THE DESK AND RETRACT TO ALLOW THE DESKTOP TO BE CLOSED.
- 13.ALL NAMEPLATES SHALL BE WHITE WITH BLACK LETTERS, AS SPECIFIED IN THE SPECIAL PROVISIONS, EXCEPT AS NOTED.
- 14. DEVICE ALPHA-NUMERIC IDENTIFIER IS SHOWN ON THE LAYOUT FOR CLARIFICATION AND SHALL NOT BE ENGRAVED ON THE DESK OR NAMEPLATES.
- 15. CONTINUOUS HINGE SHALL BE FURNISHED AND INSTALLED ON THE CONTROL DESK TOP AND DOORS. SEE SPECIFICATIONS FOR FURTHER DETAILS.
- 16. SEE ETHERNET SCHEMATIC LAYOUT ON SHEET E-29 FOR THE NODE MODULE DETAILS.
