The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on Maps #29 and #30 (including Ramps & Loops) during the following time restrictions:

DAY AND TIME RESTRICTIONS

Monday to Sunday, 6:00 a.m. to 10:00 p.m.

The Contractor shall not close or narrow a lane of traffic on Maps #27, #31 and #32 during the following time restrictions:

DAY AND TIME RESTRICTIONS

Monday to Friday, 6:00 a.m. to 9:00 a.m. Monday to Friday, 4:00 p.m. to 7:00 p.m.

In addition, the Contractor shall not close or narrow a lane of traffic on Maps #1 thru Map #28, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

1. For **unexpected occurrence** that creates unusually high traffic volumes, as directed by the Engineer.
