




A) NOTIFY THE ENGINEER THIRTY (30) CALENDAR DAYS PRIOR TO ANY TRAFFIC PATTERN ALTERATION.

- B) INSTALL ADVANCE WORK ZONE WARNING SIGNS WHEN WORK IS WITHIN 40 FT FROM THE EDGE OF TRAVEL LANE AND NO MORE THAN THREE (3) DAYS PRIOR TO THE BEGINNING OF CONSTRUCTION.
- C) PROVIDE SIGNING AND DEVICES REQUIRED TO CLOSE THE ROAD ACCORDING TO THE ROADWAY STANDARD DRAWINGS AND TRAFFIC CONTROL PLANS.

PROVIDE SIGNING REQUIRED FOR THE OFF-SITE DETOUR ROUTE AS SHOWN IN THE TRAFFIC CONTROL PLANS.

D) COVER OR REMOVE ALL SIGNS AND DEVICES REQUIRED TO CLOSE THE ROAD WHEN ROAD CLOSURE IS NOT IN OPERATION.

COVER OR REMOVE ALL SIGNS REQUIRED FOR THE OFF-SITE DETOUR WHEN THE DETOUR IS NOT IN OPERATION.

E) ENSURE ALL NECESSARY SIGNING IS IN PLACE PRIOR TO ALTERING ANY TRAFFIC PATTERN.

F) PLACE TYPE III BARRICADES, WITH "ROAD CLOSED" SIGN R11-2 ATTACHED, OF SUFFICIENT LENGTH TO CLOSE ENTIRE ROADWAY.

H) TIE PROPOSED PAVEMENT MARKING LINES TO EXISTING PAVEMENT MARKING LINES.

ADDITIONAL NOTES

- I) MAINTAIN TRAFFIC TO ALL RESIDENTS AS WELL AS FOR FARMS AND ACTIVE FIELDS THAT ARE LOCATED NEAR BOTH ENDS OF THE BRIDGE DURING LIFE OF PROJECT AND ALL PHASES OF CONSTRUCTION.

PHASE I

STEP 1

PRIOR TO ANY CONSTRUCTION OPERATIONS, PLACE AND COVER OFF-SITE DETOUR SIGNS FOR HARGRAVES RD (SR 1313), JACKSON BY-PASS RD (SR 1311), PLEASANT GROVE RD (SR 1314), AS SHOWN ON TMP-2, AND IN ACCORDANCE WITH RSD 1101.03 (SHEETS 1 OF 9).

STEP 2

USING OFF-SITE DETOUR, AS SHOWN ON TMP-2, UNCOVER DETOUR SIGNS, CLOSE -L-(SR 1313 / HARGRAVES RD) TO TRAFFIC AND CONSTRUCT PROPOSED BRIDGE AND ROADWAY UP TO AND INCLUDING THE FINAL LAYER OF SURFACE COURSE PER ROADWAY AND BRIDGE PLANS.

STEP 3


UPON COMPLETION OF BRIDGE AND ROADWAY CONSTRUCTION, PLACE FINAL PAVEMENT MARKINGS AND MARKERS IN ACCORDANCE WITH RSD 1205.01, 1205.02, 1205.12, 1250.01, 1251.01, AND PAVEMENT MARKING PLANS. REMOVE ALL SIGNS AND DEVICES, AND OPEN -L- (SR 1313 / HARGRAVES RD) TO TRAFFIC.




