MAP 4 EXIT 220 I-85 B. NB/ RANDLEMAN RD.

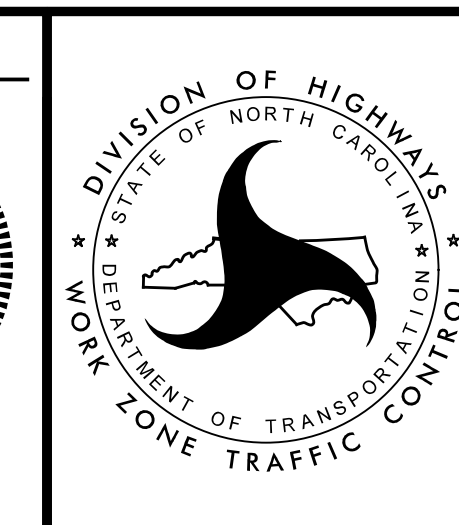
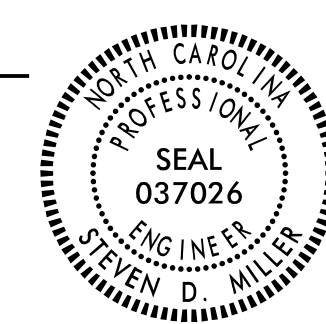

MAP 5 EXIT 220 I-40 EB/ RANDLEMAN RD.



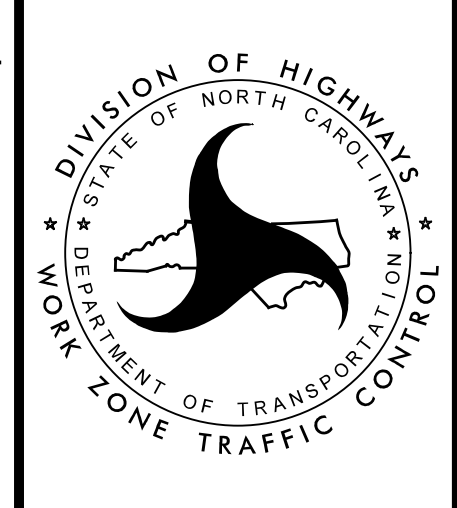
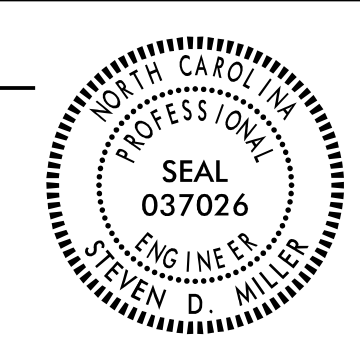
