

FOR MECHANICALLY STABILIZED EARTH (MSE) RETAINING WALLS, SEE MECHANICALLY STABILIZED EARTH RETAINING WALLS PROVISION.

FOR TYPE III REINFORCED BRIDGE APPROACH FILL, SEE BRIDGE APPROACH FILLS PROVISION AND ROADWAY DETAIL DRAWING NO. 422D10.

FOR STEEL BEAM GUARDRAIL, SEE ROADWAY PLANS AND SECTION 862 OF THE STANDARD SPECIFICATIONS.

FOR SINGLE FACED PRECAST CONCRETE BARRIER, SEE ROADWAY PLANS AND SECTION 857 OF THE STANDARD SPECIFICATIONS.

AT THE CONTRACTOR'S OPTION, USE FINE AGGREGATE IN THE REINFORCED ZONE OF RETAINING WALL NOS. 1&2.

A RUSTIC ASHLAR ARCHITECTURAL FINISH IS REQUIRED FOR PRECAST CONCRETE PANELS FOR RETAINING WALL NOS.1&2.

ARCHITECTURAL SURFACE FINISHES REQUIRE AN ADDITIONAL 2"OF PANEL OR CIP WALL THICKNESS.NO ADDITIONAL PAYMENT WILL BE INCLUDED FOR PAYMENT.ANY ADDITIONAL COSTS SHOULD BE INCLUDED IN THE COST OF SURFACE TREATMENT

A SEPARATION GEOTEXTILE IS REQUIRED AT THE BACK OF THE REINFORCED ZONE FOR RETAINING WALL NOS.1&2.

A DRAIN IS REQUIRED FOR RETAINING WALL NOS. 1&2.

DESIGN RETAINING WALL NOS. 1&2 FOR THE FOLLOWING:

BEFORE BEGINNING MSE WALL DESIGN FOR RETAINING WALL NOS.1&2, SURVEY WALL LOCATION AND SUBMIT A REVISED WALL PROFILE VIEW (WALL ENVELOPE) FOR REVIEW. DO NOT START WALL DESIGN OR CONSTRUCTION UNTIL THE REVISED WALL ENVELOPE IS ACCEPTED.

1) H = DESIGN HEIGHT + EMBEDMENT

2) DESIGN LIFE = 100 YEARS

3) MAXIMUM FACTORED VERTICAL PRESSURE ON FOUNDATION MATERIAL = 6500 PSF 4) MINIMUM REINFORCEMENT LENGTH (L) = 0.7H OR 6 FT, WHICHEVER IS LONGER


DESIGN RETAINING WALL NOS. 1&2 FOR A LIVE LOAD (TRAFFIC) SURCHARGE.

EXISTING OR FUTURE OBSTRUCTIONS SUCH AS FOUNDATIONS, GUARDRAIL, FENCE OR HANDRAIL POSTS, PAVEMENTS, PIPES, INLETS OR UTILITIES WILL OR MAY INTERFERE WITH REINFORCEMENT FOR RETAINING WALL NOS. 1&2.


DO NOT PLACE LEVELING PAD CONCRETE, AGGREGATE OR REINFORCEMENT FOR RETAINING WALLS NO.1&2 UNTIL EXCAVATION DIMENSIONS AND FOUNDATION MATERIAL ARE APPROVED.

THE MSE WALLS WILL BE STAGE CONSTRUCTED, WITH THE STAGING OCCURING 3'3"RT, -L-. "TEMPORARY SHORING" WILL BE REQUIRED FOR THE MAINTENANCE OF TRAFFIC AND WALL CONSTRUCTION. SEE ROADWAY AND STRUCTURE PLAN AND THE TEMPORARY SHORING PROVISIONS. SUBMIT ALL STAGING DETAILS AND ANY OTHER SHORING WITH THE WALL PACKAGE FOR REVIEW.

AT THE CONTRACTOR'S OPTION, "TEMPORARY SHORING FOR WALL CONSTRUCTION" MAY BE USED TO CONSTRUCT RETAINING WALL NOS. 1&2. SEE MSE RETAINING WALLS PROVISION FOR TEMPORARY SHORING FOR WALL CONSTRUCTION.
