## PUBLIC HEARING


The North Carolina Department of Transportation (NCDOT) is proposing to improve about 6.5 miles of East John Street-Old Monroe Road (S.R. 1009) from Trade Street (S.R. 3448-S.R. 3474) in downtown Matthews in Mecklenburg County to Wesley Chapel-Stouts Road (S.R. 1377) in Indian Trail in Union County. The project will improve traffic flow and efficiency as well as increase capacity for vehicles. The project will also enhance mobility for pedestrians and bicyclists. In addition, another desirable outcome for the project is to enhance overall travel and safety.

Project mapping will be displayed at the Public Hearing. Project team staff will be present to discuss the project and answer questions. Public comments are due by November 11, 2016.
