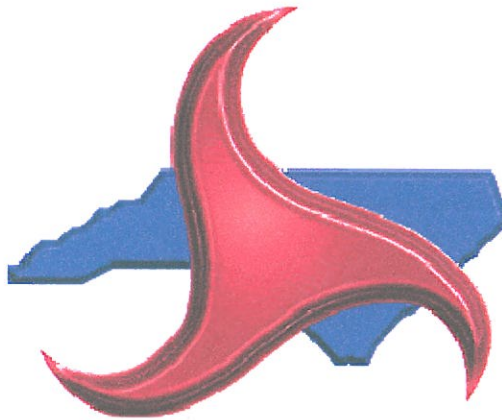

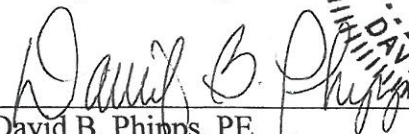

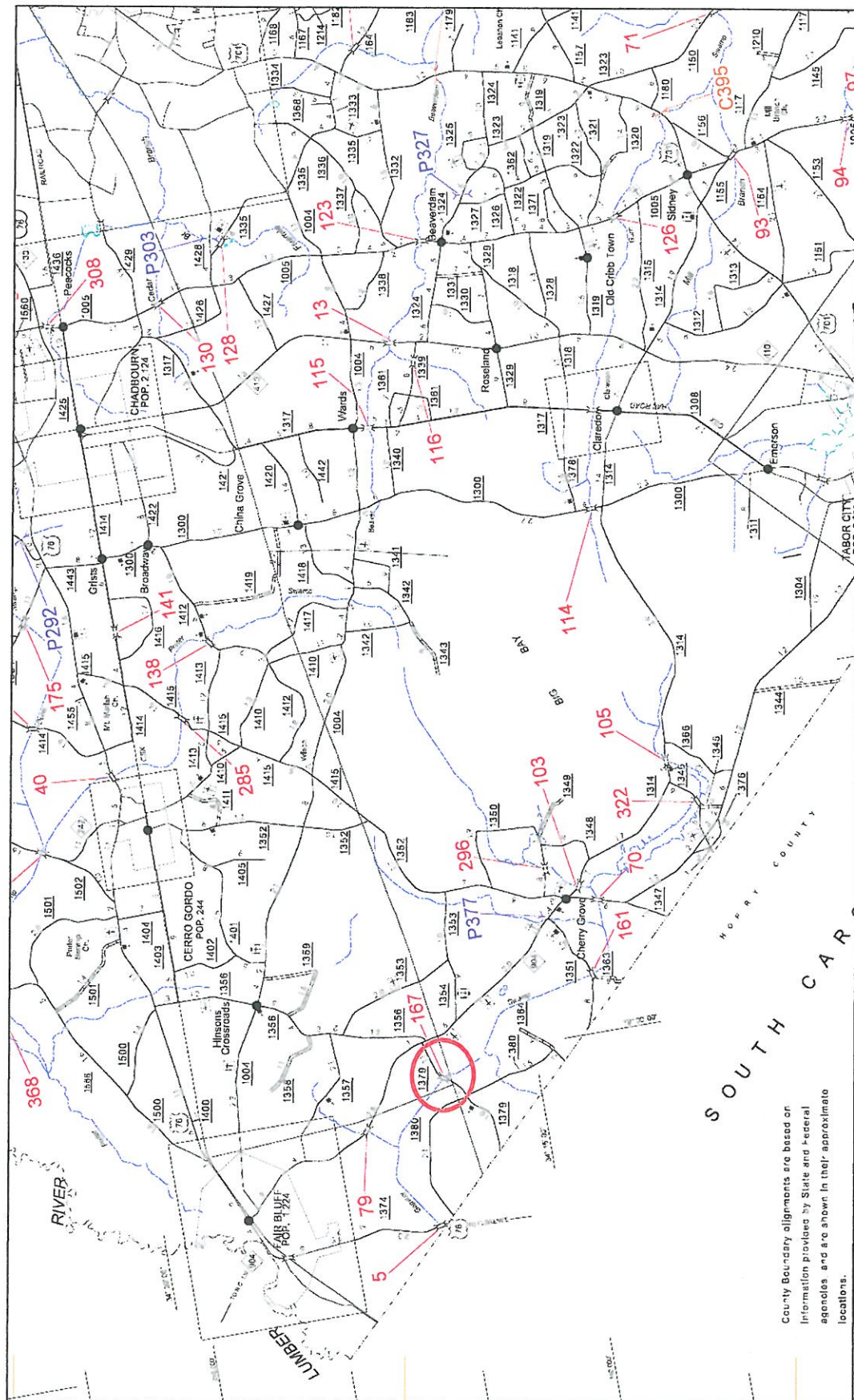

Warning Signs at Bridge Type 3 Object Markers (OM-3L and OM-3R) - 2 each. Curve Warning Sign (W1-2) with 35 mph for southbound only.
