GENERAL WARRANTY DEED

NASH COUNTY

THIS DEED made this the 25th day of November, 1996, by

(hereinafter referred to as "Grantor") and JOSIAH PETER VICK,
whose address is 1668 Taylor Store Road, Nashville, NC 27856
(hereinafter referred to as "Grantee"),

The designation Grantor and Grantee as used herein shall
include said parties, their heirs, successors, and assigns,
and shall include singular, plural, masculine, feminine or
neuter as required by context.

WITNESSETH: THAT the Grantor, for a valuable
consideration paid by the Grantee, the receipt of which is
hereby acknowledged, has and by these presents does grant,
bargain, sell and convey unto the Grantee in fee simple, all
that certain lot or parcel of land situate in Nashville
Township, Nash County, North Carolina, and more particularly
described as follows:

BEING all of that certain tract or parcel of land
containing 2 acres, more or less, lying on the northwest side
of Vick Road (S. R. 1302). Reference is hereby made to Deed
