CONTROL OF EROSION, SILTATION, AND POLLUTION

10-18-05

Revise the Standard Specifications as follows:

Page 1-50, Subarticle 107-13(A) Delete the last paragraph and insert the following:

Following completion of any construction phase or operation, on any graded slope area greater than one acre, the Contractor shall provide ground cover sufficient to restrain erosion within 21 calendar days or within a time period specified by the *Sedimentation and Pollution Control Act*. The ground cover shall be either temporary or permanent and the type specified in the contract.

BORROW MATERIAL AT SITE #1

The wasting of excess suitable material from Site #2, and the subsequent use of this material as borrow for Site #1 will be permitted without executing a supplemental agreement as required in Article 225-3 of the Specifications.

Measurement of such material excavated at Site #2 and used as borrow for Site #1 will be by Truck Measurement, as allowed by Article 230-5 of the Specifications.

Payment will be in accordance with Article 230-6.

Material required by the contract to be excavated at Site #2 will be measured and paid for in accordance with Section 225 of the Specifications, regardless of the ultimate destination of the material. In placing his bid, the Contractor shall consider the value of this material's availability for use as borrow material on Site #1.
