## **CONTRACT TIME AND LIQUIDATED DAMAGES**

07-20-04

The date of availability for this contract is the date the Contractor begins work but not before January 2, 2006 or later than March 1, 2006.

The completion date for this contract is the date that is One Hundred Eighty (180) consecutive calendar days after and including the date of availability.

When observation periods are required by the special provisions, they are not a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. Should an observation period extend beyond the final completion date, the acceptable completion of the observation period shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract shall be Five Hundred Dollars (\$500.00) per calendar day. At the preconstruction conference the Contractor shall declare his expected date for beginning work. Should the Contractor desire to revise this date after the preconstruction conference, he shall notify the Engineer in writing at least thirty (30) days prior to the revised date.
