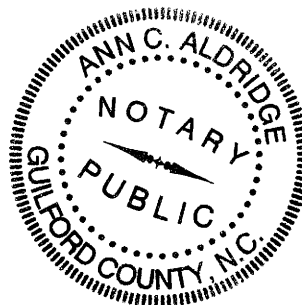

DEBARMENT CERTIFICATION OF CONTRACTOR

1.
