Except where otherwise provided by the contract, observation periods required by the contract will not be a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. The acceptable completion of the observation periods that extend beyond the final completion date shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are **Eight Hundred Dollars (\$800.00)** per calendar day.

**Description**

The Contractor shall place ABC (M) along the existing shoulders in areas where the shoulder has failed as directed by the Engineer. The area shall be backfilled and compacted to the satisfaction of the Engineer.

**Materials**

The ABC (M) shall meet the requirements of Section 1005 in the NCDOT 2006 *Standard Specifications for Roads and Structures*.

**Measurement and Payment**

*Shoulder Repair* will be measured and paid for as the actual number of tons acceptably placed. The aggregate will be measured by being weighed in trucks on certified platform scales or other certified weighing devices. Such price and payment will be full compensation for furnishing material, hauling, placing, compaction, and all incidentals necessary to complete repair of the shoulders.

Revise the 2006 *Standard Specifications* as follows:

**Division 2 Earthwork**

**Page 2-16, Subarticle 230-1(D)**, add the words: *The Contractor specifically waives* as the first words of the sentence.

**Page 2-17, Article 230-4(B) Contractor Furnished Sources, first paragraph, first sentence** replace with the following:

Prior to the approval of any borrow sources developed for use on any project, obtain certification from the State Historic Preservation Officer of the State Department of Cultural Resources certifying that the removal of the borrow material from the borrow sources(s) will have no effect on any known district, site building, structure, or object, architectural and/or archaeological that is included or eligible for inclusion in the National Register of Historic Places.
