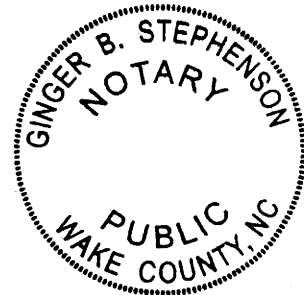

DEBARMENT CERTIFICATION OF CONTRACTOR
