Page Nos. 37 thru 49 have been revised to delete the Project Special Provision entitled "Quality Management System For Asphalt Pavements: (OGAFC, PADC and Ultrathin HMA Version)".

Page No. 56 has been revised to delete the Project Special Provision entitled "Aggregates For Asphalt Pavements and Surface Treatments (Ultra-Thin)".

Page No. 58 has been revised to delete the Project Special Provision entitled "Value Engineering Proposal For Ultra Thin Bonded Wearing Course.
