

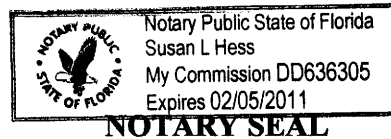

DEBARMENT CERTIFICATION OF CONTRACTOR
