Page 15-1, Subarticle 1500-2 Cooperation with the Utility Owner, paragraph 2, add the following sentences:

The Greenville Utilities Commission is owner of the 8" water facilities. The contractor must contact the owner before any work begins. Shutdown of GUC's water system is limited between the hours of 9:00 am and 3:00 pm. The contact person is Donny Hemby (phone: 252-551-3398).

Page 15-9, Subarticle 1515-2 Materials, add the following sentences:

The proposed utility construction shall meet the applicable requirements (i.e. material specifications, standard details, testing, policies, etc.) of the NCDOT's "Standard Specifications for Roads and Structures" (dated July, 2006) and GUC's "Manual for the Design and Construction of Water and Wastewater System Extension's for Greenville Utilities" (dated June, 2008).

Measurement and payment for work will be in accordance with NCDOT's "Standard Specifications for Roads and Structures" (dated July, 2006).

In addition to the water line materials specified under Section 1036, the water line can be High Density Polyethylene (HDPE) pipe conforming to AWWA C906 with an SDR of 9 and pressure rating of 200 # WP.
