HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

- 1. For unexpected occurrence that creates unusually high traffic volumes, as directed by the Engineer.
- 2. For the Blood, Sweat, and Gears Bike Race held every third Saturday in June between the hours of 12:00 a.m. the day of the race and 12:00 a.m. the day after the race.
- 3. For the Valley Country Fair held every third Saturday in October between the hours of 12:00 a.m. the day of the fair and 12:00 a.m. the day after the fair.
- 4. For the Wooley Worm Festival every third Saturday in October between the hours of 12:00 a.m. the day of the festival and 12:00 a.m. the day after the festival.

The Contractor shall schedule his work so that lane closures are not required during these periods, unless otherwise directed by the Engineer.

The time of availability for this intermediate contract time will be the time the Contractor begins to install traffic control devices required for the lane closures according to the time restrictions stated herein.

The completion time for this intermediate contract time will be the time the Contractor is required to complete the removal of traffic control devices required for the lane closures according to the time restrictions stated herein and restore traffic to a 2-lane, 2-way traffic pattern.

The liquidated damages are **Five Hundred Dollars (500.00)** per hour.

INTERMEDIATE CONTRACT TIME NUMBER 2 AND LIQUIDATED DAMAGES:

The Contractor shall complete the work required of Site 1, Step 3 and Site 2, Step 3 as shown on Sheet(s) TCP-3 and shall place and maintain traffic on same.

The date of availability for this intermediate contract time will be the date the Contractor elects to begin the work.

The completion date for this intermediate contract time will be the date which is 120 consecutive calendar days after and including the date the Contractor begins this work.

The liquidated damages are **One Thousand Dollars** (\$ 1,000.00) per calendar day.

INTERMEDIATE CONTRACT TIME NUMBER 3 AND LIQUIDATED DAMAGES:

The Contractor shall complete the work required of Local Note 1 as shown on Sheet(s) **TCP-2** and shall place and maintain traffic on same.

The time of availability for this intermediate contract time is Tuesdays and Thursdays at 12:00 PM (Noon).

The completion time for this intermediate contract time will be the time which is two consecutive hours after the time of availability.

The liquidated damages are Two Hundred Fifty Dollars (\$ 250.00) per 15 minutes.
