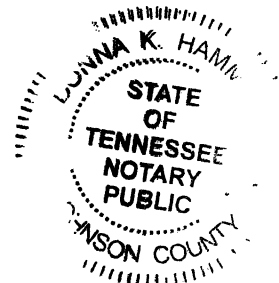

DEBARMENT CERTIFICATION
