# GeoEnvironmental Impact Evaluation Addendem to Report dated January 21,2004

Project: 34871.1.1 (TIP #: U-2826B) US 52 From I-40 Bypass to NC 66 Forsyth County

### **Purpose**

This addendum presents the results of a geoenvironmental impact evaluation conducted along Martin Luther King Jr. Boulevard on the above referenced project. This report is an addendum to the January 21, 2004 GeoEnvironmental Impact Evaluation and a supplement to the Kimley Horn Environmental Screening Report dated November 21, 2003. The main purpose of this investigation is to identify properties within the project study area that are or may be contaminated and therefore result in increased project costs and future liability if acquired by the Department. Geoenvironmental impacts may include, but are not limited to, active and abandoned underground storage tank (UST) sites, hazardous waste sites, regulated landfills and unregulated dumpsites.

# **Techniques/Methodologies Used**

The Geographical Information System (GIS) was consulted to identify known environmentally impacting sites in relation to the project corridor. GeoEnvironmental Section personnel conducted a field reconnaissance survey along the project corridor on June 20, 2007. A search of appropriate environmental agencies' databases was performed to assist in evaluating sites identified during this survey.

## **Findings**

## **Underground Storage Tank (UST) Facilities**

Based on our study, 11 sites presently or formerly containing petroleum underground storage tanks (USTs) were identified within the project limits (see Appendix A).

#### **Hazardous Waste Sites**

No Hazardous Waste Sites were identified within the project limits.

## Landfills

No apparent landfills were identified within the project limits.

#### Other GeoEnvironmental Concerns

A racecar shop was identified as a possible GeoEnvironmental Concern within the project limits.


# **Anticipated Impacts**

Eleven possible UST facilities and one racecar shop were identified within the proposed project corridor. We anticipate low to non-existent monetary and scheduling impacts resulting from these sites.

The GeoEnvironmental Section observed no additional contaminated properties during the field reconnaissance and regulatory agencies' records search. The GeoEnvironmental Section will provide soil and groundwater assessments on each of the above properties after identification of the selected alternative and before right of way acquisition. Please note that discovery of additional sites not recorded by regulatory agencies and not reasonably discernable during the project reconnaissance may occur. The GeoEnvironmental Section should be notified immediately after discovery of such sites so their potential impact(s) may be assessed.
