UTILITY CONFLICTS:

General:

The following utility companies have facilities that will be in conflict with the construction of this project:

- A. French Broad EMC
- B. Frontier Communications Corp.
- C. Charter Communications Corp.
- D. Piedmont Natural Gas
- E. Town of Burnsville

The conflicting facilities of these concerns will be adjusted prior to the date of availability, unless otherwise noted and are therefore listed in these special provisions for the benefit of the Contractor. All utility work listed herein will be done by the utility owners. All utilities are shown on the plans from the best available information.

The Contractor's attention is directed to Article 105.8 of the Standard Specifications.

The contractor shall schedule and attend a separate pre-construction utilities coordination conference prior to beginning work on the project. The Engineer and all utility owners with facilities on the project shall be invited.

Utilities Requiring Adjustment:

A. French Broad EMC

- 1. See "Utilities By Others Plans" for utility conflicts.
- 2. At areas marked LDC (Lower During Construction), the utility requires three working day's notice prior to the contractor finishing grading, and two weeks to complete construction. The lines in these areas will be kept in operation during grading. The height will be adjusted after rough grading is completed. The poles must remain supported at all times.

- 4. All other facilities will be relocated by Date of Availability.

B. Frontier Communications Corp.

- 1. See "Utilities By Others Plans" for utility conflicts.
- 2. At areas marked LDC (Lower During Construction), the utility requires three working day's notice prior to the contractor finishing grading, and two weeks to complete construction. The lines in these areas will be kept in operation during grading. The height will be adjusted after rough grading is completed. The poles must remain supported at all times.
- 3. At the intersection of -Y14- and -L-, Frontier communications has a manhole and conduit system that must be adjusted for drainage construction. Give the utility one week's notice prior to beginning construction, and allow one week to complete the work.

- 5. All other facilities will be relocated by Date of Availability.

C. Charter Communications Corp.

- 1. Charter Communications has facilities in the project area that are in conflict with the project. These facilities will be relocated to follow the power and telephone corridors.
- 2. At areas marked LDC (Lower During Construction), the utility requires three working day's notice prior to the contractor finishing grading, and two weeks to complete construction. The lines in these areas will be kept in operation during grading. The height will be adjusted after rough grading is completed. The poles must remain supported at all times.
