All proposed utility construction shall meet the applicable requirements of the Burnal Department of Transportation's "Standard Specifications for Roads and Structures" dated July 2006. Division 15 of the Standard Specifications is revised as follows:

Page 15-1, Paragraph 4

Provide access for Department personnel and the owner's representatives to all phases of construction. Notify Department personnel and the utility owner two weeks prior to commencement of any work and one week prior to service interruption. Keep utility owner's representatives informed of work progress and provide opportunity for inspection of construction and testing. The water mains on this project belong to the Town of Mount Pleasant and to the Water and Sewer Authority of Cabarrus County (WSACC). The contact person for the Town of Mount Pleasant is Mr. David Fargo, Public Works Director, and he can be reached by phone at (704) 436-2353 or by email at mppwdirector@windstream.net. The contact person for WSACC is Mr. Mark Lomax and he can be reached by phone at (704) 786-1783, extension 231. All work on these lines must be coordinated through the Engineer and the utility owner before beginning.

Page 15-9 Section 1515-2

In addition to the water line materials specified under Section 1036, water lines may be High Density Polyethylene (HDPE) pipe conforming to AWWA C906 with an SDR of 9 and a pressure rating of 200 psi with the following exception:

WSACC does not allow installation of HDPE for water or sewer lines. WSACC requires that lines with diameters of 150mm, 200mm, and 300mm be PVC, C900, DR14. The Contractor shall verify line sizes, material types and conformance to the applicable specifications prior to purchasing water or sewer pipe. Product submittals shall be provided to and approved by the Engineer prior to the purchase of the materials mentioned above.

Interruptions in water service shall be limited to a maximum of 4 hours unless otherwise specifically approved by the Engineer

COMPENSATION:

No direct payment will be made for utility construction work required by the preceding provisions, which are general requirements applying to utility construction, and all of the requirements stated will be considered incidental work, paid for at the contract unit prices of the various utility items included in the contract.
