Utility Construction

Specifications:

Revise the 2006 Standard Specifications as follows:

Utility Owner's Contact Information:

Page 15-1; Subarticle 1500-2 Cooperation with the Utility Owner, paragraph 2, add the following sentences:

The utility owners are the City of Greensboro and Guilford County Schools. The contact person for City of Greensboro is Mr. Brian Boyd and he can be reached by phone at (336)373-4131. The contact person for Guilford County Schools is Mr. Gerald Greeson and he can be reached by phone at (336)370-2385.

MEASUREMENT AND PAYMENT:

No direct payment will be made for utility construction work required by the preceding provisions, which are general requirements applying to utility construction, and all of the requirements stated will be considered incidental work, paid for at the contract unit prices of the various utility items included in the contract.

BREAK DOWN AND CAP MANHOLE:

All sewer manholes in the construction area that will require fill to be placed over the manhole shall be broken down to a point (see UC-17 for detail) above top of sewer pipe and a concrete slab 5 inches thick placed over the top, then backfilled in a manner acceptable to the Engineer. Prior to placement of the slab, a steel arch pipe section shall be installed over the inlet channel and 1500 psi concrete be placed over the top of the arch.

The quantity of sewer manholes broken down, capped, and accepted will be measured and paid for at the contract unit price each for "Break Down and Cap Manhole". Such prices and payments will be full compensation for all materials, labor, breaking down manhole, steel arch pipe section, concrete fill, placing cap, excavation, backfilling, and incidentals necessary to complete the work required.
