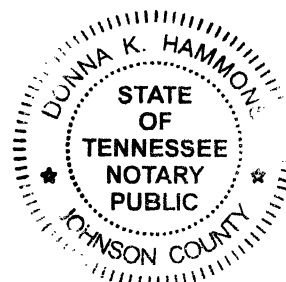

DEBARMENT CERTIFICATION
