The date of availability for this contract is **February 27, 2012**, except that work in jurisdictional waters and wetlands shall not begin until a meeting between the DOT, Regulatory Agencies, and the Contractor is held as stipulated in the permits contained elsewhere in this proposal. This delay in availability has been considered in determining the contract time for this project.

The completion date for this contract is November 1, 2015.

Except where otherwise provided by the contract, observation periods required by the contract will not be a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. The acceptable completion of the observation periods that extend beyond the final completion date shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are Two Thousand Eight Hundred Dollars (\$2,800.00) per calendar day.

The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on **Freeway Drive/US 29 Business (-L-)** during the following time restrictions:

#### DAY AND TIME RESTRICTIONS

Monday through Friday from 6:00 A.M. to 9:00 P.M. Saturday and Sunday from 8:00 A.M. to 9:00 P.M.

In addition, the Contractor shall not close or narrow a lane of traffic on Freeway Drive/ US 29 Business (-L-), detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:
