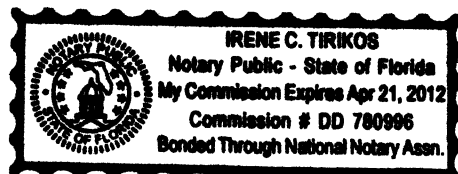

DEBARMENT CERTIFICATION
