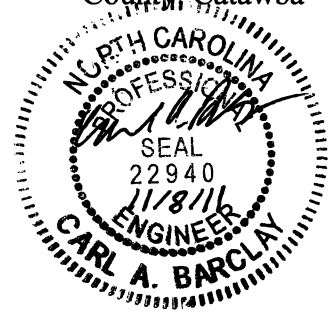


**Project Special Provisions**  
Utility Construction



Revise the 2012 *Standard Specifications* as follows:

**Utility Owners' Contact Information:**

**Page 15-1, Subarticle 1500-2 Cooperation with the Utility Owner**, paragraph 2, add the following sentences:

1. The existing water main belongs to Catawba County/City of Conover. The county contact person is Mr. Jonathan Greer at 828-464-6411. The city contact person is Mr. Jimmy Clark at 828-464-4808. The contractor shall provide access for the owner's representatives to all phases of construction. Any work on these lines must be coordinated through the Engineer and the utility owner before beginning.
2. The existing water line shall not be shut down during construction.

## ENGINEERS REPORT FOR WATER MAIN REPLACEMENT

This report covers the relocation of a water main involved in NCDOT Project B-4061, WBS 33425.1.1. These facilities serve Catawba County customers and are owned by:

The existing facility along SR 1727 (Boggs Road) at the bridge crossing of Hagan Creek is being relocated in kind and will not affect the ability of the water utility to provide service. A 12" DIP water main will be relocated to avoid conflict areas and will require 615' of 12" water main to serve the existing requirements. There will be no increase in service area or new demands on the capacity of the water service. This replacement has been reviewed by the owner and is in keeping with the long-range plans of this water utility at this time.

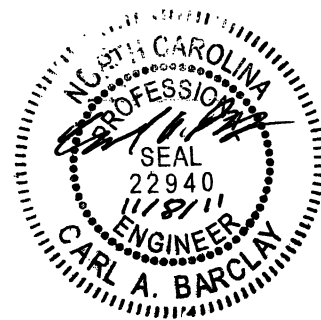

UTILITIES BY OTHERS:

## General:

The following utility companies have facilities that will be in conflict with the construction of this project.

- A) CenturyLink – Telephone
- B) Duke Energy – Power Distribution

The conflicting facilities of these concerns will be installed, adjusted, removed or abandoned prior to the date of availability, unless otherwise noted and are therefore listed in these special provisions for the benefit of the Contractor. All utility work listed herein will be done by the utility owner. All utilities are shown on the plans from the best available information.

The Contractor's attention is directed to Article 105-8 of the 2012 Standard Specifications.

## Utilities Requiring Adjustment:

- A) CenturyLink – Telephone
  - 1) CenturyLink will abandon, adjust, relocate or remove its facilities at the locations within the project limits as shown on the Utilities by Others Plans.
  - 2) Contact person for CenturyLink is Ms. Amy McClain at 828-328-0345.
- B) Duke Energy – Power Distribution
  - 1) Duke Energy will adjust, relocate or remove its facilities at the locations within the project limits as shown on the Utilities by Others Plans.
