PROJECT SPECIAL PROVISIONS Utility Construction

All proposed utility construction shall meet the applicable requirements of the NC Department of Transportation's Standard Specifications for Roads and Structures dated January 2012.

Revise the 2012 Standard Specifications as follows:

Utility Owners' Contact Information:

Page 15-1, Subarticle 1500-2 Cooperation with the Utility Owner, paragraph 2, add the following sentences:

Water and sanitary sewer lines on this project belong to Town of Clayton and Johnston County.

The Contractor shall provide access for the owner's representatives to all phases of construction and keep all valves and meters accessible during construction. A preconstruction meeting shall be held with Town of Clayton, Johnston County, the Utility Contractor and D.O.T. prior to any work beginning. The Contractor shall notify the owner two weeks before commencement of any work and three weeks before service interruption.

The proposed utility construction shall meet the applicable requirements:

The contractor shall provide a set of as-built plans to Town of Clayton and Johnston County after all the work shown on the Utility Construction Plans is completed.

The contractor shall replace the existing fire hydrants that are relocated with a new fire hydrant supplied by Town of Clayton. The contractor shall contact the Town of Clayton to schedule delivery of the existing fire hydrants.

Page 15-6, Subarticle 1510-3-(A) Construction Requirements, change the allowable leakage formula and use continuous feed method for chlorination of water lines:

W=LD(P)1/2 /148,000

Flush the water line prior to sterilization to remove all debris and dirt. Use the continuous feed method for chlorinating the water line in accordance to AWWA C651, Section 4.4.3.
