PROJECT SPECIAL PROVISIONS Utility Construction

All proposed utility construction shall meet the applicable requirements of the NC Department of Transportation's Standard Specifications for Roads and Structures dated January 2012.

Revise the 2012 Standard Specifications as follows:

Utility Owners' contact Information:

Page 15-1, Subarticle 1500-2 Cooperation with the Utility Owner, paragraph 2, add the following sentences:

All water lines and sewer lines on this project belong to City of Morganton and the State Broughton Hospital Utilities.

The Contractor shall provide access for the owner's representatives during construction. A preconstruction meeting shall be held with the City of Morganton and State Broughton Hospital Utilities, the Utility Contractor and the D.O.T prior to any work beginning. The Contractor shall notify the owner two weeks before commencement of any work and three weeks before service interruption.

The contractor shall provide access for the owner's representatives to all phases of construction. Any work on these lines must be coordinated through the Engineer and the utility owner before beginning.

The contractor shall provide a set of as-built plans to City of Morganton and State Broughton Hospital after all the work shown on the Utility Construction Plans is completed.

Page 15-8, Subarticle 1510-3-(A) Construction Requirements, change the allowable leakage formula and use continuous feed method for chlorination of water lines:

W=LD(P)^{1/2}/148,000

Flush all the water lines prior to sterilization to remove all debris and dirt. Use the continuous feed method for chlorinating all the water lines in accordance to AWWA C651, Section 4.4.3.

The Contractor's attention is directed to Article 105.8 of the Standard Specifications.

Utilities Requiring Adjustment:

A) City of Morganton

City of Morganton will relocate the aerial power line from I-40 to Sterling Drive and will complete the relocation by September 1, 2012.

City of Morganton will have a temporary line crossing I-40 interchange on the West side by May 10, 2012 and the line will be moved permanently to the East side of I-40 after the project is complete.

City of Morganton will relocate the aerial power line from beginning of the project to I-40 and will complete the relocation by February 1, 2013.
