

PROJECT SPECIAL PROVISIONS

Utility

UTILITIES BY OTHERS:

General:

The following utility companies have facilities that will be in conflict with the construction of this project.

- A) City of Lexington - Power (Distribution)
- B) City of Lexington - Water (Distribution)
- C) City of Lexington - Natural Gas (Distribution)
- D) Time Warner - Cable TV
- E) Windstream Communications - Telephone

The conflicting facilities of these concerns will be adjusted prior to the date of availability, unless otherwise noted and are therefore listed in these special provisions for the benefit of the Contractor. All utility work listed herein will be done by the utility owner. All utilities are shown on the plans from the best available information.

The Contractor's attention is directed to Article 105-8 of the Standard Specifications.

Utilities Requiring Adjustment:

- A) City of Lexington - Power (Distribution)
 - 1) City of Lexington will abandon its existing facilities and relocate its poles and lines within the project limits at the locations shown on the Utilities by Others Plans prior to date of availability.
 - 2) Contact person for City of Lexington is Mr. Steve Potts at 336-240-2086.
- B) City of Lexington - Water (Distribution)
 - 1) The City of Lexington will abandon its existing facilities and relocate its water lines and facilities within the project limits at the locations shown on the Utilities by Others Plans. The contractor will give the City two weeks notice prior to closure of the road and will allow the City three days to complete their work after closure of the road.

C) City of Lexington - Natural Gas (Distribution)

- 1) The City of Lexington will cap and abandon its existing lines within the project limits at the locations shown on the Utilities by Others Plans. The contractor will give the City two weeks notice prior to closure of the road and will allow the City three days to complete their work after closure of the road.
- 2) Contact person for City of Lexington is Mr. Andy Thomas at 336-240-1972.

D) Time Warner Cable TV - Cable TV

- 1) Times Warner Cable will abandon its existing lines and attach new lines to the proposed new City of Lexington power poles within the project limits at the locations shown on the Utilities by Others Plans prior to date of availability.

E) Windstream Communications - Telephone

- 1) Windstream Communication will abandon its existing poles, overhead lines and underground lines and relocate to the new City of Lexington power poles and connect to existing underground and overhead lines within the project limits at the locations shown on the Utilities by Others Plans prior to date of availability.
